- be aware of the labour market mechanisms, and of the employee-employer relationships, act on career decisions responsibly, understand the significance of lifelong learning;
- use basic mathematics and the basic principles of physics and chemistry when needed in daily situations;
- work with the means of information and communication technologies, exploit adequate sources of information, handle information effectively;
- act in an environmentally-conscious manner and in compliance with strategies for sustainability;

- prepare meal plans for patients with unproblematic disease, including calculations of biological and energy value under the expert supervision of nutritional therapist based on medical indication individual;
- take part in the education of individuals, families and groups in the field of healthy food healing diets;
- take part in the delivery, inspection, handling and storage of food for particular nutrition;
- take part in the delivery, inspection, handling and storage of therapeutic and medical devices;
- take part in the disinfection and sterilization of medical devices and ensure their adequate stocks;
- work the medical records.



## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The graduate is employed in catering operations within health and social facilities, in the state health institutions, in the state administration carrying out state health surveillance and in the community care. He/she can find employment as a specialist in facilities providing nutritional and dietetic care, especially in dietary dining rooms, clinical and outpatient medical facilities, educational centers, spas and sanatoriums, social care facilities and geriatric care facilities, especially in treatment centers for long standing illnesses and within day care centers. He/she also work as a nutritional consultant.
